OPTN/UNOS Membership and Professional Standards Committee (MPSC) Meeting Minutes January 8, 2019 Conference Call

Introduction

The Membership and Professional Standards Committee met by conference call and GoToTraining on January 8, 2019, to discuss the following agenda items:

- 1. Member Related Actions
- 2. Committee Actions

The following is a summary of the Committee's discussions.

1. Member Related Actions

The Committee is charged with determining whether member clinical transplant programs, organ procurement organizations, histocompatibility laboratories, and non-institutional members meet and remain in compliance with membership criteria. During each meeting, it considers actions regarding the status of current members and new applicants.

The Committee reviewed applications and status changes and will recommend that the Board of Directors take the following actions when it meets in June 10, 2019:

- Fully approve 7 new transplant programs in existing transplant hospitals
- Conditionally approve 3 new transplant programs in existing transplant hospitals

The Committee also reviewed and approved the following actions:

- 11 Changes in transplant program and living donor component personnel
- 3 Changes in histocompatibility lab personnel
- 1 Extension of conditional program status

In addition, the Committee discussed a key personnel change application for a change in primary surgeon at a heart transplant program.

Hospital Based OPO Voting Privileges Implementation: The Committee reviewed five applications from hospital based OPO's requesting voting status. The Committee will recommend that the Executive Committee approve the changes in voting status for the five OPOs when it meets on January 16, 2019.

Informal Discussion Updates: During the meeting, the Committee discussed follow-up reports from two hospitals that had participated in informal discussions. It will continue to monitor both hospitals.

2. Committee Actions

The Committee unanimously agreed that actions regarding Bylaws, Policy, and programspecific decisions made during the OPTN session would be accepted as UNOS actions.

RESOLVED, that the Committee accepts those program specific determinations made during the meeting as UNOS recommendations.

FURTHER RESOLVED, that the Committee also accepts the recommendations made relative to Bylaw and Policy changes.
