# OPTN Membership and Professional Standards Committee (MPSC) Meeting Summary December 17, 2019 Conference Call with GoToTraining

#### Introduction

The Membership and Professional Standards Committee (MPSC) met by conference call via Citrix GoToTraining on December 17, 2019, to discuss the following agenda item:

The following is a summary of the Committee's discussions.

#### 1. Membership Requirements Revision Project

Staff provided an update on relevant topics from the OPTN Board of Directors meeting in early December. The Board of Directors approved the new MPSC charge. In addition, the MPSC chair provided the annual MPSC update to the Board addressing changes in informal discussion and interview activity following implementation of revisions to Appendix L of the OPTN Bylaws, update on the implementation of the pediatric component membership bylaws and updates on various MPSC projects. Staff gave an overview of the updated project plan for Phase 1 of the Membership Requirements Revision project and a summary of actions taken on the Membership Requirements Revision Subcommittee call on December 6, 2019. The Committee was informed of the next steps for this project including an MPSC update to be delivered by regional representatives at the upcoming regional meetings. Finally, staff informed the Committee that staff would be requesting feedback soon on a new CMS proposed rule on OPO outcomes measures that was announced on the same day as the conference call meeting.
