# OPTN Liver and Intestinal Organ Transplantation Committee National Liver Review Board (NLRB) Subcommittee Meeting Summary January 13, 2022 Conference Call

#### Introduction

The National Liver Review Board Subcommittee (the Subcommittee) met via Citrix GoToMeeting teleconference on 01/13/2022 to discuss the following agenda items:

1. Ongoing Review of NLRB Diagnoses

## 1. Ongoing Review of NLRB Diagnoses

The Subcommittee discussed the next round of NLRB diagnoses.

## Summary of discussion:

A member suggested the Subcommittee should review *Policy 9.5.B: Requirements for Cystic Fibrosis (CF) MELD or PELD Score Exceptions,* as new CF medications and treatments have recently been developed. Another member suggested the need for a forced expiratory volume at one second (FEV1) cutoff for CF should be reassessed.

The Subcommittee determined they would begin to review *Policy 9.5.C: Requirements for Familial Amyloid Polyneuropathy (FAP) MELD or PELD Score Exceptions* by consulting with FAP subject matter experts (SMEs).

The Subcommittee also determined the next round of diagnosis review will include guidance for Bud Chiari, Hepatic Epithelioid Hemangioendothelioma, Hereditary Hemorrhagic Telangiectasia, Multiple Hepatic Adenomas, and Pruritus.

Additionally, the Subcommittee will review criteria listed in *Policy 9.5.E: Requirements for Hepatopulmonary Syndrome (HPS) MELD or PELD Exceptions* to determine if a candidate with severe HPS should be considered for a higher model for end-stage liver disease (MELD) exception score.
