# OPTN Transplant Administrators Committee Meeting Summary June 28, 2023 Conference Call

#### Introduction

The OPTN Transplant Administrators Committee (the Committee) met via Citrix GoToMeeting teleconference on 6/28/23 to discuss the following agenda items:

#### 2. Fiscal Impact Advisory Group Report

UNOS staff provided a brief summary and explanation of the Fiscal Impact Advisory Group (FIG). They informed the Committee of the discussion that the FIG had relating to the three proposals reviewed at the June 1<sup>st</sup> FIG meeting.

#### Summary of Discussion:

Members who participated in FIG provided their feedback on the new process. One member asked if there might be a way to include more quantifiable numeric costs in the questions relating to whether a fiscal impact is high, medium, or low. They acknowledge that this can vary from program to program and were open to further discussion on how to adequately ascertain quantitative data on the FIG analysis. The Chair emphasized that the new questions might need adjusting depending on the proposal being reviewed, but overall they were able to give a substantive analysis of the proposals.

Members were reminded of regional meetings coming up and the start of Public Comment on July 27<sup>th</sup>. Those members who would be rolling off the Committee were encouraged to attend their regions meeting and to provide feedback on public comment items during the Public Comment period from July 27 – September 19.
