Introduction

The OPTN Pancreas Transplantation Committee (the Committee) met via Citrix GoToMeeting teleconference on 06/16/2023 to discuss the following agenda items:

1. Public Comment Continuous Distribution (CD) Overview of Themes/Feedback
2. Preview: Summer 2023 Public Comment kidney-pancreas (KP) CD Committee Update and Request for Feedback (RFF)
3. Recognition of Member Service

The following is a summary of the Committee's discussions.

1. Public Comment Continuous Distribution (CD) Overview of Themes/Feedback

The Committee heard a CD overview of themes and feedback received from the January 2023 public comment cycle. The themes and feedback are as follows:

- General support for CD
 - Several OPTN Committees, OPOs, regions, and individuals support CD overall.
 - Some comments recognized the challenges of balancing waitlist mortality with long-term outcomes and the difficulty of reaching decisions on prioritization
 - Region 1 in particular, in support of building an initial framework to mimic the current system
- Review Boards
 - Several comments supportive of the creation of review boards
 - Appreciate consideration for more complex situations that may warrant an exception
- Pediatric Priority
 - American Society of Transplantation (AST)- Concerns that CD efforts are not considering pediatric candidates. Increasing availability to more KP recipients risks causing further inequity among pediatric patients
- Prior Living Donor Priority
 - Significant number of comments from patients, living donors, and stakeholder organizations expressing concern for potential de-prioritization of living donors; concerns of disincentivizing living donation and violating public trust in the system
- Calculated Panel Reactive Antibody (CPRA)
 - Several Comments support priority for highly sensitized candidates, especially CPRA 99.99%+
 - American Society of Transplant Surgeons (ASTS) suggested that high CPRA candidates are currently over-prioritized; equals access for CPRA groups
- Disparities

- Concerns for a potential decrease in transplant rate for Black candidates as shown in some organ allocation simulator (OASIM) results
- AST- Committee should avoid scenarios that exacerbate socioeconomic disparities; increased weight on proximity efficiency could contribute to increased geographic disparities
- Consider additional metrics for population and program density
- Region 6- concern for increased travel distance and how that will impact their region, which has low population density and unique considerations for travel and logistics
- Efficiency
 - Significant number of comments related to efficiency; one commenter stated that this should be the first priority
 - Concerns for increased distance in OASIM
 - ASTS- program should be required to adjust distance acceptable to their program
 - Distance is an important factor for cold ischemic time (CIT)
 - Consider cost of travel and organ acquisition
 - Need for a national transport system
- Increase Utilization of Pancreata
 - Suggestion that more local priority may improve pancreas-alone utilization
- Facilitated Pancreas
 - Several commenters noted concern with allocating pancreata more broadly
 - ASTS- suggested facilitated pancreas should encompass some standard offer attempt
- Modeling and Data
 - Concerns about the results of the first OASIM report
 - More data and modeling are needed
 - Suggestion- CD should only move forward if data supports the new framework would be better than the current system
 - Support for mathematical optimization
 - Considerations for future modeling and data review
 - Individual program reports with CAS scores
 - Test match runs
 - Objective and measurable criteria
 - Model any HLA matching prioritization for unintended disparities
- Communication and Education
 - Recommend more transparency and clear messaging on Committee's work and project progress
 - Consider enhanced communications and education on allocation system for both patients and professionals

Summary of discussion:

The Vice-Chair asked when the second OASIM report will be available. Staff replied that the results will be available in July 2023.

2. Preview: Summer 2023 Public Comment KP CD Committee Update and Request for Feedback (RFF)

Staff informed the Committee that there would be a committee update and request for feedback that will go out for the July 2023-August 2023 public comment cycle. The purpose of the committee update and request for feedback is to:

- Update the community on the project progress to include the Committee’s considerations and discussions leading into the second OASIM request.
- Provide an overview of discussions/decisions on efficiency topics from the Utilization Considerations Workgroup and across the OPTN.
- Ask specific questions to inform the Committee’s decisions leading into the eventual proposal.
