

# **Meeting Summary**

OPTN Heart Committee Meeting Summary December 6, 2023 Conference Call

#### Introduction

The Heart Committee ("Committee") met via WebEx teleconference on 12/06/2023 to discuss the following agenda items:

The following is a summary of the Committee's discussions.

## 1. Continuous Distribution (CD) Hearts: Overview of pediatric waiting time consideration

The workgroup lead provided updates on pediatric waiting time criteria considerations.

#### Summary of discussion:

The discussion started with a question posed by the Chair, who asked the members how they think priority should be allocated to appropriately account for longer waiting times among pediatric candidates. Support staff noted that although precise numbers are not needed yet, that the Committee should discuss whether points are allocated using the medical urgency attribute or the patient access attribute. The Chair clarified that continuous distribution would help with "tiebreakers." A member noted that the perception of waiting time is important to include from the patient perspective. The Vice Chair noted that although the perception of waiting time is important, the conversation should focus on pediatrics.

#### Next steps:

The workgroup will work toward adjusting the formula in CD for pediatric patients.

#### 2. Other Committee Business

The Committee discussed public comment and regional meeting dates, in addition to the new policy changes to Amend Adult Heart Status 2 Mechanical Device Requirements proposal.
