Introduction

The MPSC Membership Requirements Revision Subcommittee met in open session virtually via Webex on May 23, 2024, to discuss the following agenda items:

The following is a summary of the Subcommittee's discussions.

1. Review outstanding issues from May 21, 2024, MPSC Meeting for Membership Requirements Revision Proposal; finalize proposal

Staff reviewed the contents of the *Update Membership Requirements and Application Review Process* proposal with the Subcommittee and noted the following additional small tweaks made to the proposal following full MPSC's consideration of the Subcommittee's recommendations at its May 21, 2024, conference call:

- Non-substantive change to primary surgeon and primary physician letter of recommendation requirements in Appendices E – J to accommodate removal of transplant program director from bylaws
- Modifications to finalize definition of "Additional Obstetrician-Gynecologist" as recommended by the Vascular Composite Allograft (VCA) Committee for inclusion in the program coverage plan requirements
- Modifications to finalize language for Appendix D requirement for notification to patients and the OPTN of changes in program coverage plan after full Committee discussion and vote on language options at its May 21 Committee meeting

Summary of Discussion:

A member asked whether it would be possible to address currency requirements and unclear phrasing of required timeframes for transplant program key personnel requirements. Staff clarified that there would be the opportunity to do so as part of the next project phase which will look at requirements for transplant program key personnel.

The Subcommittee expressed no concerns and expressed support for release of the proposal for summer 2024 public comment.

OPTN staff will present the proposal and Subcommittee recommendation to the full MPSC during the May 29, 2024, Committee meeting. Work on the next phase of the project will begin at the July 2024 Committee meeting, and Subcommittee meetings will resume after that meeting.
