# OPTN Lung Transplantation Committee Meeting Summary November 14, 2024 Conference Call

## Introduction

The OPTN Lung Transplantation Committee (the Committee) met via WebEx teleconference on 11/14/2024 to discuss the following agenda items:

- 1. *Modify Lung Donor Data Collection* Proposal: Review recommendation from Promote Efficiency of Lung Allocation Workgroup
- 2. Vote: Modify Lung Donor Data Collection, January 2025 public comment

The following is a summary of the Committee's discussions.

1. *Modify Lung Donor Data Collection* Proposal: Review recommendation from Promote Efficiency of Lung Allocation Workgroup

The Committee reviewed the Workgroup's recommendations on draft data fields and data definitions. They also completed a review of the mockups for each new data field in the OPTN Computer System.

#### Summary of discussion:

Decision #1: The Committee made an addition to the Peak Inspiratory Pressure (PIP) data definition to specify that PIP values are reported in ventilator settings alongside Arterial Blood Gases (ABGs).

The Committee reviewed the Workgroup's recommendations on draft data fields and data definitions. During this discussion a member suggested a small change to data definition for Peak Inspiratory Pressure (PIP), to specify that PIP values are reported in ventilator settings alongside Arterial Blood Gases (ABGs). The Committee agreed that this addition to the data definition would help specify how when and how to report PIP values.

#### 2. Vote: Modify Lung Donor Data Collection, January 2025 public comment

The Committee determined they were prepared to vote on submitting proposed policy language for *Modify Lung Donor Data Collection proposal* for January 2025 public comment.

## Summary of discussion:
