## OPTN Transplant Coordinators Committee Meeting Summary March 18, 2020 Conference Call

#### 1. HRSA Organ Donation Outreach Materials: Request for Feedback

#### 3. PTR Refusal Codes Project Updates

UNOS IT staff presented on the current progress of the PTR refusal codes project.

Summary of discussion:

The Committee is highly supportive of this project. They had the following suggestions:

- Adding a code for donor recovery timing constraint
- Split the code for recovery team not available into center recovery team not available and local recovery team not available, especially with the implementation of broader sharing
- Keep the transplant team workload code
- Unblinding the reason for "898" organ-specific test refusal

The Committee also recommended providing an educational offering on using a secondary code once the new refusal codes are implemented.

UNOS IT staff asked if they had a preference on using numerical codes or simply listing the decline reasons. The Committee felt that implementation would be successful and the interface would be usable with any of the suggested IT solutions.

UNOS IT staff will take back the suggestions of the Committee members to the project workgroup.

## 4. Continuous Distribution: AHP/Decision Lens Prioritization Exercise

- Declining offers from donors that exhibit any potential symptoms, since testing is sparse
- Additional advance screening for COVID symptoms in potential recipients
